SHRI C.S. CHADHA


Heard both the learned counsel for the parties.

The subject matter of this OA is with regard to the pay scales of Technical Assistants and Technical Supervisors working in the hospitals of Delhi Administration. An Anomaly Committee was set up to examine their grievances after the Vth Pay Commission gave its recommendations. According to the applicants, the Anomaly Committee, which was set up on 18.2.2000, has already furnished its report to the Govt. of India, but the same has not been decided by the Govt. despite lapse of more than three years. In the interest of justice all that is required to be done is to issue a direction to the respondents to take an appropriate decision by a well reasoned order within a limited period of time. Such matters should not remain undecided indefinitely.


3. We, therefore, dispose of this OA with a decision to the respondents to take a final decision on the recommendations of the Anomaly Committee, if
