Shri S.A.T. Rizvi:


The applicants, ninety in number, all Senior Auditors under the Ministry of Defence, seek pay parity with the Assistants of the Central Secretariat Service.

2. According to the learned counsel appearing on behalf of the applicants, an identical matter had come up before this Bench in OA-1442/2002 which was decided on 31.5.2002 with a direction to the respondents to consider the claims of the applicants in terms of the decision rendered by this Bench in OA-1664/2001. By ~~the~~^{an} order passed on 11.4.2002, we had allowed the aforesaid OA ^(NO.1664/2001) with a direction to the respondents to implement the decision made by the Guwahati Bench in OA-85/2000 in favour of the applicants in that OA.

3. On consideration, we find the present OA can also be disposed of at this very stage even without issuing notices with a direction to the respondents to consider the claims of the applicants in the present OA in accordance with the decisions rendered by this Tribunal in the aforesaid cases. This be done by them expeditiously and in any case within a period of three months from the date of receipt of a copy of this order. We direct accordingly.
