2. MA-1581/2002 for joining together in one application is allowed.

3. As per the averments made in the OA, the applicants are aggrieved by the alleged arbitrary action of the respondents in not granting regular pay scales to the applicants on their attaining temporary status and thereby denying them pay scales as drawn by regular employees posted on identical posts.

4. Learned counsel for applicants submits that no written representation has been filed by the applicants till now regarding the aforesaid grievance. He further submits that the applicants will file a self contained representation within three weeks from today and the matter can be disposed of at the admission stage itself by giving a direction to the respondents to dispose of the said representation within a particular time frame.

5. On consideration of the matter, the OA is being disposed of at the admission stage itself with the following directions:-

- (a) The applicants may submit a comprehensive and self contained representation regarding their grievance to the respondents within three weeks from today. The respondents are directed to examine the same on its merits in

the light of the relevant rules, instructions and judicial pronouncements on the subject and dispose of the matter by a detailed and speaking order under intimation to the applicants within two months from the date of receipt of the said representation.

(b) In case any grievance further servives, the applicants are given the liberty to approach this Tribunal again in fresh original proceedings, if so advised, in accordance with law.

6. A copy of the OA may be sent to the respondents alongwith a copy of this order.
