BY HON'BLE SHRI SHANKER RAJU, MEMBER (J)

In view of the order passed by the respondents on 11.4.2001 in compliance to this Tribunal's order dated 14.2.2001 in OA No. 338/2001 rejecting the request for revision of pay scale on the recommendations of DoPT, the said order has come to the notice of the applicant only during the course of hearing, learned counsel for the applicant Shri Shyam Babu seeks liberty to withdraw this OA with further liberty to file fresh OA.

2. In the interest of justice we allow the same with the observations that limitation will not come in the way of filing afresh OA. OA is accordingly dismissed as having been withdrawn with liberty to file fresh O.A.
