M.A. 1259/2002 is allowed subject to just exceptions. Filing of the joint application is permitted.

O.A. 1562/2002

2. The applicants in the present O.A. are Senior Auditors in the Department of Defence Accounts. They seek parity of pay scale with the Assistants of Central Secretariat Service and the Senior Auditors in I.A. and A.D.


3. In support of their claim, the applicants have placed reliance on the decision of this Tribunal in




O.A.85/2000 decided on 19.1.2001 titled Shri Hiranmoy Sen & others vs. Union of India & others by the Guwahati Bench. This matter had even been considered by the Principal Bench in the case of R.K.Malik & others vs. Union of India & others (O.A.No.1442/2002) decided on 31.5.2002.

4. It is unfortunate that the respondents do not follow the said decisions and similarly situated persons have to rush to this Tribunal more often than once. Once the similar matters have already been adjudicated by this Tribunal, we find no reason to take a different view because all those decisions have become final with respect to certain similarly situated persons.

5. Accordingly we direct the respondents to grant the benefit of the decisions rendered by this Tribunal referred to above with consequential benefits to the applicants.
