Heard Shri Rajinder Nischal, learned counsel of the applicant. Applicant's claim is that he has been holding current charge of the post of Executive Engineer (EE(E) since 1994 and has been appointed as EE(E) on ad hoc basis since 1999. According to him the applicant is eligible for regularisation for the post of EE(E) ^{as} by way of promotion, as he has completed 8 years service/Assistant Engineer (AE (E) on 1.1.1993 / 24.10.1994. He is a candidate for such promotion in the backlog quota reserved for SC. Learned

counsel further stated that although proposal for such promotion has been made to UPSC but the applicant's name is not reported to have been indicated among the eligible candidates.

2.. In view of the claims made above on behalf of the applicant, we are of the considered view that interest of justice will be duly served, if at this stage itself and without issuing notices to the respondents, they are directed to consider the claim of the applicant as per rules and reservation roster for promotion as EE(E) under the special drive on the same basis as his three colleagues were promoted in 1991 w.e.f. 1.1.1993 on completion of 8 years service as AE(E) by taking into account his ad-hoc service w.e.f 1.1.85 to 23.10.1986 or w.e.f. 24.10.1994 when he completed 8 years regular service as AE(E). In case applicant is found fit for promotion, he should be accorded appropriate seniority and other consequential benefits except back wages. Ordered accordingly.

3.. O.A. is disposed of as above..
