**O R D E R (ORAL)**

**Hon'ble Smt. Lakshmi Swaminathan, Vice-Chairman (J) :**

Learned counsel for parties have submitted that the aforesaid CPs, four in number, arise out of similar directions of the Tribunal (Principal Bench) as were given in the order dated 11.7.2002 in OA No.1764/2002.

2. In the above circumstances, we reproduce below the observations and directions of the Tribunal in the order dated 11.7.2002 in OA No.1764/2002 :

"The applicants in the present OAs who are Senior Auditors in the Defence Accounts Department and working in the offices of Controller of Defence Accounts (Army), Controller of Defence Accounts (Training) and Controller of Defence Accounts (Training) Meerut, seek parity in pay scales with the Assistants of the Central Secretariat Service. When a similar matter came up before us in OA No.1664/2001 in Shri R.C.P.Singh & Ors. Vs. Union of India & Ors., we had, by placing reliance on the decisions taken by the Madras and the Guwahati Benches of the Tribunal in similar cases, issued a direction on 11-4-2002 to the respondents to implement the decision rendered by the Guwahati Bench in OA No.85/2000 in favour of the applicants in that OA.

As the facts and circumstances in the present OA are identical to the facts and circumstances of OA No.85/2000, we see no harm in proceeding similarly in the present OA and accordingly we find it in order even at this stage to direct the respondents to consider the claims of the applicants in the present OA in terms of the decision rendered by us in the aforesaid OA as expeditiously as possible and take a decision thereon within a maximum period of three months from the date of receipt of a copy of this order. We direct accordingly. We further find it in order to direct the respondents to grant the benefit of the judgment rendered by us to all others who

might be similarly placed in their organisation. The OA is disposed of in the aforestated terms".

3. Since a reference has been made to OA No.85/2000, it is also necessary to see the directions of the Tribunal (Guwahati Bench) in OA No.85/2000 in the order dated 19.1.2001 which read as follows :

"14. We have given our anxious consideration on the issue and in our considered opinion the reasons cited in the impugned order dated 4.2.2000 only reflect the extraneous considerations, overlooking the relevant considerations. The reasons cited in clause 9 on the purported ground of alleged disagreement in the JCM cannot be upheld on the basis of the earlier finding on the issue by the Tribunal in O.A. No.45 of 1992. The impugned order dated 4.2.2000 is accordingly set aside and the respondents are directed to implement the order of the Tribunal dated 2.11.1994 in O.A. No.45/92 as well as the order dated 14.9.1999 in O.A. No.63/1997 forthwith and to give all consequential benefits to the applicants forthwith."

4. As the directions of the Tribunal (Guwahati Bench) in OA No.85/2000 specifically referred to the directions given to the respondents to implement the order of the Tribunal in two other OAs, namely, OA No.45/1992 and OA No.63/1997, we have also seen those orders. They are reproduced below for ready reference. Operative portion of the order dated 2.11.1994 in OA No.45/1992 (Guwahati Bench) reads as follows :

"We however feel that we will be better advised to leave the matter for fresh and proper decision by the respondents. The respondents can always review their own decision when necessary. We would therefore recommend to the respondents in the interest of justice to re-examine the question and take a suitable decision afresh without postponing the issue to the report of the Fifth Central

Pay Commission. We do not make such a direction or stipulate a time limit as we have no doubt that the reasons that have persuaded us to make the recommendation as reflected in the foregoing discussion will receive due and expeditious attention from the respondents. The fresh decision whichever way it may be taken however shall be communicated to the applicants.

In the result, subject to the recommendation made above to the respondents the application is disposed of. It is made clear that this order will not preclude the applicants in any manner to represent their case before the 5th Central Pay Commission whether a fresh decision is taken or not by the respondents as recommended by us."

The operative portion of the Tribunal's (Guwahati Bench) order in OA No.63/1997 dated 14.9.1999 reads as follows :

".....We therefore have no hesitation of coming to the conclusion that the respondents did not properly scrutinise the findings of this Tribunal given in O.A.45/92 dated 2.11.1994 and also the spirit of the judicial pronouncements. Mr. Deb Roy while supporting the action of the respondents has cited some decisions of the Supreme Court that the Tribunal/Courts should not play a role of an employer by interfering with the pay scale. This is in our opinion, a well settled principle. But we feel that the order passed by this Tribunal which reached its finality, has not been fully complied with. The Tribunal having come to the conclusion that the nature of job, qualification, responsibility of the Senior Auditors are same or similar with that of Assistants historically, they had been given the same scale of pay. Even the expert body like Fourth Central Pay Commission also give similar scale. Government had already taken a decision. We find no justifiable ground to make a departure from that decision of the Government earlier taken. Accordingly we direct the respondents to consider the true spirit and direction given in the judgment dated 2.11.1994 passed in O.A.45/92 and to pass necessary and appropriate orders regarding the parity of pay. This must be done as early as possible, at any rate, within a period of 4 months from the date of receipt of this order."

5. Having seen the aforesaid judgments of the Tribunal on the basis of which the order of the Tribunal in the instant case has been passed, we are unable to agree with the contentions of the learned counsel for applicants that there was a direction to respondents to grant the revised pay scales from any particular date, i.e., 1.1.1986, as claimed. It is clear from the relevant directions of the Tribunal in the aforesaid OAs as quoted above that a direction was given to the respondents to consider the claims in the true spirit and pass appropriate orders. No specific date has been indicated by the Tribunal in the various orders. Shri M.M.Sudan, learned Senior Counsel for respondents, has submitted that in terms of the aforesaid orders of the Tribunal and in particular the order dated 11.7.2002, respondents have issued O.M. dated 28.2.2003 (Annexure R-1). It is noticed that the pay scales of the posts mentioned in the OM dated 28.2.2003 have been revised in various Ministries/Departments of the Government of India and accordingly upgraded on notional basis w.e.f. 1.1.1996 with actual payments from 19.2.2003, i.e., the date on which the decision was approved by the Government, even though the OM itself has been issued on 28.2.2003.


6. The learned counsel for applicants has sought reliance on the orders of the Hon'ble Delhi High Court, Hon'ble Guwahati High Court and Hon'ble Himachal Pradesh High Court, which he says have a bearing on the present CPs. We are unable to agree with this contention because according to the learned counsel for applicants himself,


the above four CPs have been filed for alleged non-implementation of the Tribunal's orders (Principal Bench) dated 11.7.2002 in OA No.1764/2002 and other related OAs. Taking into account the totality of the facts and circumstances of the case and the various orders of the Tribunal quoted above and the submissions of the learned counsel for applicants as well as the learned Senior Counsel for respondents, we do not find any justification to continue with the CPs as it cannot be held that the respondents have committed any wilful or contumacious disobedience of the orders in taking action in implementation of the Tribunal's orders.

7. In view of the above, CP No.57/2003 in OA No.1764/2002, CP No.58/2003 in OA No.1782/2002, CP No.59/2003 in OA No.1765/2002 and CP No.60/2003 in OA No.1781/2002 are dismissed. Notices to the alleged contemners are discharged. Files be consigned to the record room.

8. Let a copy of this order be placed in CP-58/2003, CP-59/2003 and CP-60/2003.
