ORDER (ORAL)

Heard arguments on C.P.

2. Vide order dated 7.6.2002, the applicants who  
were appointed as Lecturers on contract basis, the

operation of the impugned order dated 8.3.2002 was stayed and the respondents were directed to continue the applicants as contractual lecturers.


3. While in this Contempt Petition, it is contended that although the applicants have been allowed to continue but they have not been paid salaries for the period they have worked.


4. In these circumstances, the present Contempt Petition is disposed of with a direction to the respondents to pay the salary to the applicants, if not already paid, on the strength of interim order passed on 7.6.2002, within a period of 15 days from today.

5. Shri J.A. Chaudhary, learned proxy counsel for the respondents states that the issues involved in the present case are in all fours covered by the decision dated 24.7.2002 of this Tribunal in OA No.580/2002 in the case of Prakash Chandra Vs. Lt. Governor and others.

6. In this view of the matter, list the present OA for possible final hearing on 15.11.2002.

7. Subject to aforesaid C.P. is disposed of and the notices issued to the alleged contemnors are discharged.
