2. Heard Shri Deepak Verma, learned counsel of the applicants.

3. The applicants, ten in number, are EDP Data Entry Operators-A (DEO-A) at the headquarters of Staff Selection Commission (in short 'SSC'), New Delhi. The learned counsel stated that the 5th Central Pay Commission (in short 'CPC') enhanced the pre-revised scale of DEOs-A from Rs.1150-1500 to that of Rs.1320-2040 and recommended revised pay scale of Rs.4000-6000 for DEOs-A w.e.f. 1.1.96 (Annexure A-1). The aforesaid revised pay scale has been implemented by Govt. of India in respect of EDP/DEOs-A working in various Ministries and Departments such as Ministry of Agriculture, Department of Statistics and even the Regional Offices of SSC. Drawing our attention to Annexure A-5, the learned counsel stated that one Shri Sanjay Gurvekar who is junior to applicants Shri R.P.Mathur and Ms.Jaswant Kaur as DEO-A, has been accorded the revised pay scale of Rs.4000-6000 as per Annexure A-4 dated 28.12.99 furnishing details of DEO-A at SSC (M.P.). It is alleged that respondents have not yet given the applicants the revised pay scale of Rs.4000-6000 w.e.f. 1.1.96 as admissible to DEOs-A. The applicants have made representation/reminder (Annexures A-6 and A-7) for

refixation of their pay in the corrected revised scale of Rs.4000-6000 w.e.f. 1.1.96 with consequential benefits, which have remained unresponded.

4. Having regard to the claims made and documentary proof furnished regarding the implementation of the revised scale of Rs.4000-6000 in various Govt. of India Ministries/Departments as well as Regional Office of SSC, at this stage itself we find that interests of justice will be duly met if the respondents are called upon to dispose of the applicants' aforesaid representations by passing a reasoned and speaking order within a period of two months from the date of communication of these orders. We direct accordingly. No costs.
