ORDER (ORAL)

HON'BLE DR K B SURESH, MEMBER (J)

Heard. The matter is in a very small compass. Apparently applicant had been considered for compassionate appointment only once i.e. 14.10.2015. Subsequently based on the orders of this Tribunal in OA.No.802/2016 dtd.28.6.2017, the case of the applicant was placed before the Committee of Compassionate Engagement(CCE) on 13.10.2017 and again on 15.02.2018 and on both occasions, the decision was referred to the next CCE awaiting clarification from the Postal Directorate. Apparently, once again the CCE met on 16.5.2018 but decided that as per the Postal Directorate letter dtd.30.05.2017, the old cases cannot be reopened. Therefore, it appears that the case of the applicant based on his eligibility has not been considered on merits in the CCE meetings held in 2017 and 2018. He is eligible for a minimum of three times of consideration according to the circular issued by the DOPT. Therefore, let him be considered for such a position after vacancies have been marshalled along with suitable others within a period of next six months. OA is disposed of as above. No order as to costs.
