ORDER (ORAL)HON'BLE DR K.B.SURESH, MEMBER (J)

It is trite law that while temporary status service and the regular service can be counted for pension, the service rendered as a casual labourer cannot be taken into account for grant of pension according to the rules. Applicant relies on the judgment of the Hon'ble High Court of Delhi which probably many not be appropriate in the circumstances of the case. Therefore, the OA lacks merit.

2. The OA is dismissed. No order as to costs.
