1. Heard. The matter is in a very small compass. Apparently, the applicant had completed more than 3 years of cumulative service. The department had held a selection, in which there were 5 people who were selected and none of them elected to join. That leaves that the post is still vacant. As the applicant seems to be the only aspirant for the post and he has already worked for 3 years with the respondents and therefore, become eligible for being included in the list as provided in the rules. There is no rhyme & reason available to reject his application. Therefore, we declare that applicant is eligible to be appointed to that post and be continued in that post under the rules as available and extant as of now.
2. OA is, allowed. Benefit to be extended to the applicant within the next two months. No order as to costs.
