**SANJEEV KAUSHIK, MEMBER (J):-**

On a plea raised by the respondents that the applicant has an alternative remedy of appeal to the Director General, Sports Authority of India against the order passed by the Executive Director, learned counsel for the applicant seeks permission to withdraw this O.A. with liberty to file an appeal.
