Applicant is a partially blind person who had approached this Tribunal on an earlier occasion by filing O.A No.801/2007 and the same had been allowed. Subsequently, by orders issued on January 10, 2018, a copy of which is at Annexure A-3, his pay was revised by giving the benefit of 2006 pay revision. His case is that he is entitled to get the benefit of the subsequent pay revision as well. Pointing out this, he has submitted two representations to the respondent no.2, copies of which are available at Annexure A-4 and Annexure A-5. No reply has been given to these representations yet.

2. We are of the view that the Original Application can be disposed of at this stage by directing respondent no.2 to consider the representations on merit and dispose of the same within thirty days from the date of receipt of a copy of this order.
