This application having been heard on 31st January, 2020, the Tribunal on the same day delivered the following :

ORDER (ORAL)

HON'BLE Mr.ASHISH KALIA, JUDICIAL MEMBER

The applicants are engaged as Casual Labourers (Skilled/Unskilled) with the respondents for more than 10 years in Andaman Lakshadweep Harbour Works, Amini Island, under the direct control of Ministry of Shipping. They are seeking temporary status in accordance with the rules and schemes available.

2. Issue notice to the respondents. Mr.Ratheesh.H, ACGSC accepts notice on behalf of the respondents.

3. Learned counsel for the applicants submits that the applicants have made representation to the Deputy Chief Engineer, Kavaratti Island, U.T of Lakshadweep seeking the above said relief. Learned counsel for the applicants, during the course of argument, submits that it will suffice the applicants if a direction is given to the respondents for considering the representation and dispose of the same within a stipulated time. Learned counsel for the respondents has not opposed the same.

4. This Tribunal is of the view that this matter can be decided at the

admission stage itself with a direction to respondent no.3 to pass a speaking order on the representation filed by the applicants within a period of 90 days by communicating a copy of the decision to them. Ordered accordingly. With the above observation, the Original Application is disposed of. No costs.
