The OA having been heard on 3<sup>rd</sup> March, 2020, this Tribunal delivered the following order on the same day:

**ORDER (oral)**

Sufficient opportunity was granted to the applicants' counsel to get instructions from his clients. The counsel has not received any instructions for withdrawal of the case. At the same time, they have no objection in terms of para 7 of the MA (in OA 836/18) which is reproduced below:

*"7. It is humbly submitted that presently 10 candidates are waiting to be appointed in the combined category of Sr. Commercial cum Ticket Clerk in Level 5 (Graduate Quota) and Commercial cum Ticket Clerk in Level 3 (Non Technical Popular Categories) under the Scheme of compassionate Ground Appointment and their appointment is put on hold in pursuance of the interim order."*

2. Let the respondents proceed further giving appointment on compassionate grounds. However, the cadre re-structuring ordered by the Railway Board vide RBE No.28/2018 is no longer in existence. So nothing survives in this OA. The OA is dismissed as infructuous. All the MAs are decided accordingly.
