**ORDER (ORAL)**

**HON'BLE Mr.E.K.BHARAT BHUSHAN, ...ADMINISTRATIVE MEMBER**

Heard both sides. Learned counsel representing the Navodaya Vidyalaya Samiti admitted that none has been posted in the place of applicant in Kasaragod and the respondents are agreeable to allow the applicant to continue at Kasaragod. However, it is reiterated that he is not entitled to transfer on spouse protection in view of the fact that the applicant's spouse is only working in an aided institution and is not eligible for concession. Hence, it is maintained by the Navodaya Vidyalaya Samiti that the applicant must necessarily participate in the Annual Transfer Drive of 2020 and on this condition the applicant may be allowed to continue at Kasaragod.

2. Under the circumstances, we direct that the applicant may be allowed to continue at Kasaragod and he shall participate in the Annual Transfer Drive of 2020 and await further orders from the respondents thereafter. The Original Application stands disposed of. No costs.
