ORAL ORDER

{ per Hon'ble Mr. Justice L. Narasimha Reddy, Chairman }

This OA is filed with a prayer to declare the action of the respondents i.e. BSNL in notifying the vacancies referable to the years 2000 and 2001 for Limited Departmental Competitive Examination for filling up of 35% quota of Junior Telecom Officers from amongst the eligible Telecom Technical Assistants without exhausting the candidates who took part in the examination conducted in the year 2000 and also for induction training as per the Recruitment Rules 2001; as illegal, arbitrary and consequently direct the respondents to absorb the applicants in the vacant posts JTOs which arose in the years 2000 and 2001.

2. The applicants contend that they took part in the examination that was held in the year 2000 and 2001 and though they have been waiting for posting orders for the past 13 years, the respondents have taken recourse to the candidates who took part in the subsequent examinations.

3. No counter affidavit is filed by the respondents.

4. We heard Mr.Bhim Singh representing Mr.G.Jyothi Eswar, learned counsel for the applicants. None for the respondents.

5. The applicants state that they are working as Junior Telecom Officers and that they have appeared in the screening test conducted in the year 2000. It

is also stated that the respondents corporation has taken a decision as one time measure to absorb those Telecom Technical Assistants who have appeared in the screening test in the year 2000 and for induction training as Junior Telecom Officers and despite that a notification was issued on 23.02.2013 proposing to conduct a Limited Departmental Competitive Examination for the purpose of filling up of those vacancies.

6. It may be true that the applicants have cleared screening test in the year 2000. However, the participation therein, by itself does not confer benefit upon them. Respondents have issued notification dated 23.02.2013 proposing to conduct the Limited Internal Competitive Examination (LICE). If the applicants are qualified they can appear therein and if they are not qualified, they have to wait for the proper time.

7. We do not find any merit in the OA and the same is dismissed. There shall be no order as to costs.
