**ORDER (ORAL)**

**MR. SANJEEV KAUSHIK, MEMBER(J):-**

1. MA No. 061/1314/2019 is allowed. Applicants are allowed to join together and file this application jointly.
2. On the request of the learned counsel for the parties, this matter is taken up for disposal today.
3. The present OA has been filed by six applicants seeking a direction to the respondents to consider and regularize their services as per seniority on the same analogy and parameters, while keeping in view the principle of seniority, by giving them same treatment as has been given to their juniors who were working as casual labourers in other farms under Northern Command from due date with all consequential benefits, arrears of pay etc. and interest @ 12% thereupon from date the amount became due till the actual release thereof.
4. Heard Sh. Rohit Seth, learned counsel for the applicant who alleges discrimination and submits that persons junior to the applicants in different farms in one command have been regularized whereas the applicants who are senior, have been left out. Therefore, he prays that directions be issued to the respondents to consider the claim of the applicants for regularization in terms of seniority circulated by them and regularize their services from the date when the services of their juniors were regularized.
5. Considering the short prayer, as noticed above, I dispose of this OA, at this stage, by directing the respondents to consider the prayer of the applicants and if persons junior to them are found to have already been regularized, then, the case of the applicants be also considered accordingly. This exercise be



carried out within a period of three months from the date of receipt of a certified copy of this order. No costs.
