ORDER (ORAL)

Bidisha Banerjee, Member (J):

Heard Ld. Counsels for both the parties.

2. This O.A. has been preferred by the applicant to seek the following reliefs:

- "a) to issue direction upon the respondents and their men and agents to consider the case of the applicant for posting in North Presidency Division as his daughter is appearing for the ICSE Board Examination forthwith;*
- b) to issue appropriate necessary direction upon the respondents and their men and agents not to act upon the impugned order dated 06.02.2020 till disposal of this case;*
- c) Any other order or orders....."*

3. The applicant is basically aggrieved with the inaction of the respondents in not giving her posting at North Presidency Division on her promotion to LSG Cadre from PA Cadre and instead she has been posted to Bengal Enamel SO vide impugned letter dated 06.02.2020 (Annexure-A/12 to the O.A.). Ld. Counsel for the applicant submits that the applicant, ventilating her grievance, had made several representations before the authorities and last one is dated 16.01.2020

(Annexure-A/9 to the O.A.) before the Post Master General, Kolkata Region (Respondent No.5). He further submits that the grievance of the applicant may be redressed if her representation is considered by Respondent No.5 within a specific time frame.



4. In view of the above, without going into the merits of the O.A., we dispose of this O.A. with direction to Respondent No.5, to consider the representation dated 16.01.2020 and dispose of the same with a reasoned and speaking order within a period of two months from the date of receipt of a copy of this order. We make it clear that till a detailed speaking order is issued, applicant will not be forced to join the place of transfer.

5. The O.A. is disposed of accordingly. There shall be no order as to costs.
