2. Ms. Neeta Bagare, learned proxy counsel for Shri  
C.P.Sengaonkar, learned counsel for the respondents.

3. At the outset, the learned proxy counsel for the applicants  
submits that the impugned advertisement issued in November, 2015  
has probably been cancelled by issue of fresh advertisement in all



respect, but she needs to verify. Further, it is noticed in regard to the relief claimed for regularization, various period of service have been claimed by the eleven applicants but only appointment orders of 2014 that have been produced after walk-in-interview of the year 2014. It is also noticed that the circumstances of each applicant are different. Taking all these aspects into consideration, the learned proxy counsel for the applicants has taken instructions from the applicants and Advocate on record Shri Amol D.Joshi and seeks permission to withdraw this OA to file a better formulated OA. The permission is accordingly granted.

4. Hence, this OA is dismissed as withdrawn with liberty to file properly formulated OA in respect of each applicants, if so legally advised, within a period of four weeks. No costs.
