ORDER
[HON'BLE SANJEEV KAUSHIK, MEMBER (J)]

1. This order shall dispose of a bunch of above captioned thirteen (13) Original Applications, as these involve identical questions of facts and law and minor variation in facts, here and there, would not make any difference on ultimate outcome of the cases and like wise is also requested by the learned counsel for the parties. For reference, the facts are being taken from O.A.No.060/01362/2019 – **MES WORKERS UNION ETC. VS. UNION OF INDIA & OTHERS.**

2. The applicants lay challenge to the letter dated 15.11.2019 (Annexure A-5) and 18.12.2019 (Annexure A-6), whereby the respondents have decided to recover the amount of Dress Allowance paid to them, during the years 2017-18, 2018-19 and 2019-20 and they have also sought for a declaration that the Industrial employees are also entitled to Dress Allowance in terms of the OM dated 31.8.2017 (Annexure A-1) issued by Department of Personnel & Training (DoP&T) and 2.8.2017 (Annexure A-2) issued by Ministry of Finance, Department of Expenditure, New Delhi.



3. Before addressing the arguments raised by the learned counsel for the parties, the facts may be recapitulated in the first instance. The applicants are working in the Military Engineer Service (MES) on various posts like Fitter General Mechanic (FGM), Highly Skilled Grade-I, Elect. Mate, Carp, Painter, master Craftsman (MCM) etc. They fall within the term "Industrial Employees" and belong to Group-C.

4. Prior to implementation of the 7th Central Pay Commission Report, the industrial employees (applicants) were provided 'Dangri' (dress) on yearly basis, with washing allowance per month. On the recommendations of the 7th CPC, the respondents stopped providing same to the applicants w.e.f. 1.1.2016. The Government of India, Ministry of Finance, issued OM dated 2.8.2017 (Annexure A-11), whereby a decision was taken that existing orders relating to uniform related Allowance, Clothing Allowance, Initial Equipment allowance Kit Maintenance Allowance, Robe Allowance, Robe Maintenance Allowances, shoe Allowance, Uniform Allowance and Washing Allowance are subsumed in a single Dress Allowance of Rs.5000/-per annum, w.e.f. 1.7.2017.



Subsequently, a clarification was issued by Government of India, DoPT, vide memo dated 31.8.2017, indicating that all the existing orders relating to admissibility of Uniform allowance/Washing allowance/Stitching Charges/Shoe Allowance etc. to common categories of Group-C and erstwhile Group-D employees of various Ministries/Department including attached / subordinates offices who are supplied uniform and are required to wear them regularly, shall be paid Dress Allowance @ Rs.5000/- per year. In para 2 of the O.M. it was also mentioned that the Uniform allowance/Washing Allowance/Stitching Charges/Shoe Allowance have been subsumed in Dress Allowance.

5. Pursuant to the Office Memorandums dated 2.8.2017 and 31.8.2017, respondent No.6 [Principal Controller of Defence Accounts (Western Command), Sector-9, Chandigarh], (for short "PCDA, Chandigarh") issued letter dated 5.6.2018, intimating that the benefit of Dress Allowance, as per DoPT OM dated 2.8.2017, may be extended to the Civilian employees of MES, including industrial personnel. PCDA, Chandigarh, issued another circular dated 2.8.2018 (Annexure A-4), vide which all the subordinate offices



were directed to grant Dress Allowances to the Industrial/non-industrial employees, who were wearing uniform and / or drawing washing allowances, w.e.f. 1.7.2017. In compliance thereof, the respondents granted Dress Allowance to the applicants for the year 2018-19 vide order dated 1.9.2018 (Annexure A-6). Sanction was also granted on 7.8.2019 (Annexure A-7), for grant of Dress Allowance, for the year 2019-20 as well and applicants were released this benefit also.

6. However, vide letters dated 15.11.2019 issued by PCDA and then by Defence Accounts Department, it was decided that amount of dress allowance paid, if any, to MES industrial employees, during the years 2017-18, 2018-19 and 2019-20, may be recovered immediately, as entitlement of Dress Allowance to industrial employees of MES is yet to be decided and presently, they are not entitled to dress allowance. The recovery orders were also issued on 18.12.2019. Against these orders, the applicants are before this Tribunal, challenging the same. They have taken various grounds for invalidation of the impugned orders of stoppage of Dress Allowance and recovery of payment already made to them.



7. On notice of motion, the respondents filed written statement wherein they do not dispute about the factual accuracy. However, it is submitted that since payment of washing allowance to category of applicants was made wrongly, it is permissible for the administration, under the law, to rectify its mistake and make recovery, from such persons who have been granted benefit due to wrong interpretation of the policy decisions. Till date no decision has been taken to grant the benefit of Dress Allowance to the category of the applicants and as such they are not entitled to it, in terms of the OM dated 2.8.2017 and 31.8.2017. On clarification / directions issued by PCDA, the orders of recovery have been passed. Therefore, it is submitted that there is nothing wrong in withdrawing the benefit from the applicants, to which they are not entitled to.

8. The learned counsel for the applicants vehemently argued that the orders of withdrawal and recovery of Dress Allowance is in violation of principles of natural justice as the applicants were neither put on notice nor heard before passing the impugned orders, thus, the same are illegal. It is further argued that the orders of recovery are also in violation of the decision of the



Hon'ble Apex Court in the case of **STATE OF PUNJAB AND OTHERS VS. RAFIQ MASIH**, 2015 (1) SCT 195.

Thus, it is pleaded that the impugned orders be quashed and set aside. Lastly it is pleaded that in terms of the Memorandums dated 2.8.2017 and 31.8.2017, even the applicants are entitled for grant of Dress Allowance, which was correctly granted to them in implementation of the 7th CPC recommendations which cannot be taken away from them arbitrarily.

9. Per contra, learned counsel for the respondents argued and submitted that since the applicants have wrongly been given the benefit under the directions of PCDA and on realising that it was a mistake, the same was rectified and as such they have rightly withdrawn the benefit from the applicant and ordered orders of recovery. It has also been argued by learned counsel for the respondents that the decision in the case of Rafiq Masih (supra) would not help the applicants as they had given undertakings that if it is found that there is some error in making the payment, then same may be recovered from them.



10. I have given my thoughtful consideration to the entire matter and have perused the record with the able assistance of learned counsels for the parties.

11. The two office memorandums dated 2.8.2017 and 31.8.2017, which are relevant for decision on the issue of grant of Dress Allowance, in this case, are reproduced as under :-

"New Delhi, 2nd August 2017

OFFICE MEMORANDUM

Subject: Implementation Of the recommendations of the Seventh Central pay — Dress Allowance

Consequent upon decisions by Central Government on the recommendations of the Seventh Central pay Commission, in supersession of the existing orders relating to Uniform related Allowances viz Clothing Allowance, Initial Equipment Allowance, Kit Maintenance Allowance, Robe Allowance, Robe Maintenance Allowance, Shoe Allowance, Uniform Washing Allowance which have been subsumed in a single Dress Allowance, the President is pleased to decide the rates of Dress Allowance in r/o the following categories of Central Government employees as under:

2. Allowances related maintenance, washing of Uniforms are subsumed in Dress Allowance and will not be payable separately.

3. Further categories of staff were earlier being provided Uniforms, will hence forth not be provided With uniforms.

4. The amount of Dress Allowance shall be credited to the salary of employees directly once a year in the month of July.

5. This allowance covers only the basic uniform of the employees. Any special clothing like that provided at Siachen Glacier or inside submarine or fluorescent clothing provided to Trackmen or Indian Railways or to IB personnel posted at high altitudes will continue to be provided by concerned Ministry as per existing norms.

6. Outfit Allowance paid to Indian Foreign Service officers and employees will continue to be provided as before, is enhanced by 50%.

7. The rates of Dress Allowance go up by 25% each time Dearness Allowance rise by 50%.

8. These orders shall take effect from 01st July, 2017.
xxx."

The office memorandum dated 31.8.2017 is reproduced as under:-

"Dated: August 31, 2017

OFFICE MEMORANDUM

Subject: Implementation of recommendations of the Seventh Central Pay Commission on Dress Allowance – regarding.

The undersigned is directed to state that in pursuance of the decisions taken by the Government on the recommendations of Seventh Central Pay Commission, and in supersession of the existing orders relating to admissibility of Uniform Allowance/ Washing allowance/ Stitching Charges /Shoe allowance, etc to common



categories of Group 'C' and erstwhile Group 'D' employees of various Ministries/Departments, including attached/ subordinate offices, who are supplied uniform and are required to wear them regularly, they shall be paid Dress Allowance at the rate of Rs. 5000/- per year.

2. The Uniform Allowance / Washing Allowance / Stitching Charges / Shoe Allowance, etc. have been subsumed in Dress Allowance.

3. The categories of Staff who were earlier being provided uniforms if any, shall henceforth not be provided with uniform.

4. Allowance related to maintenance and washing of uniform is subsumed under Dress Allowance, and will not be payable separately.

5. The amount of Dress Allowance shall be credited to the salary of employees directly once a year in the month of July.

6. The rate of Dress Allowance shall be, as mentioned in para-1 above, Rs.5000/- per year. The rate of Dress Allowance shall go up by 25% every time the Dearness Allowance rises by 50%.

7. This allowance covers only the basic uniform of the employees. Any special clothing will continue to be provided by the concerned Ministry as per existing norms.

8. This order shall take effect from 1st July, 2017."

12. A perusal of the OM dated 2.8.2017 would disclose that Ministry of Finance has taken a conscious decision that in supersession of earlier orders relating to various allowances viz. Clothing, Initial Equipment, Kit maintenance, Robe, Robe maintenance, Show, Uniform and Washing etc. Dress Allowance was sanctioned and category of staff, who was to be supplied uniforms and were required to wear them regularly like Trackmen, Running Staff Railways, Staff Car Drivers, MTS, Canteen Staff of Non-Statutory Departmental Canteens



etc. was sanctioned a sum of Rs.5,000/- per annum and these various allowances were subsumed, no other allowance was to be paid. Pursuant to this memo, the DoP&T, nodal Department, also issued Office memo dated 31.8.2017, which clearly provides that Uniform Allowance/Washing allowance/Stitching Charges/Show Allowance etc. have been subsumed in Dress Allowance which shall be Rs.5,000/- per annum. which shall be credited to the salary of employees directly once a year in the month of July. As per para 7, this allowance covers only the basic uniform of the employees and any special clothing will continue to be provided by the concerned Ministry, as per existing norms. In compliance thereto, the PCDA, Chandigarh, vide decision dated 5.6.2018 (Annexure A-3), clearly indicated that benefit of OM dated 2.8.2017, may be extended to the civilian of MES including industrial personnel. Again there is a letter dated 2.8.2018 (Annexure A-4), indicating that competent authority has clarified that Dress Allowance is payable to industrial/non industrial employees w.e.f. 1.7.2017. Thereafter, the applicants were granted the benefit of Dress Allowance for the years 2017-18 to 2019-20.



13. It is quite surprising that all of a sudden, the respondents have passed the impugned orders conveying that there is not even a decision as yet for grant of Dress Allowance to the category of the applicants and as such the payment of allowance already made may be recovered, as clarified by PCDA, Chandigarh, and as such impugned orders of recovery were passed, that too in violation of the principles of natural justice. A perusal of both reproduced OMs would make it clear that a conscious decision was taken by the Ministry of Finance, Department of Expenditure, New Delhi and then DoP&T (Nodal Department), pursuant to implementation of the 7th CPC recommendations, for grant of Composite Dress Allowance, instead of various allowances, which were discontinued, @ Rs.5,000/- per annum. The respondents have also not rebutted the averments made by the applicants that they stopped receiving the washing allowances from the date they started getting Dress Allowance @ Rs.5000/-per annum. Be that as it may, the fact remains that since a specific clarification has already been issued by the nodal Department of Personnel & Training, for grant of such allowance to the



entitled categories, therefore, the view taken by respondents in withdrawing the same from the applicants and making recovery thereof cannot be sustained and as such the impugned orders in all these cases are quashed and set aside. The applicants are held entitled to grant of Dress Allowance and if any recovery has been made, the same be refunded to the relevant individuals involved in these cases. No costs.
