**ORDER (ORAL)**

**Justice L. Narasimha Reddy, Chairman :-**



In this batch of OAs, the grievance of the applicants is that the relaxation of age limits, provided for in the advertisement itself, is not being extended to them, on the ground that the posts, for which they applied, are in Group 'B' and that the relaxation is available only to Group 'C' and 'D' posts.

2. Today, it is brought to our notice by the learned counsel for applicants that the respondents issued Corrigendum dated 13.02.2020, to the effect that the relaxation in favour of meritorious sportspersons is applicable to Group 'B' posts also.

3. In that view of the matter, the grievance of the applicants stand redressed. The OAs are, accordingly, closed as infructuous.

Pending MAs, if any, shall stand disposed of.

There shall be no orders as to costs.
