O R D E R (Oral)

Shri Shanker Raju:

As none present for the counsel for applicant, Rule 15 of
the CAT (Procedure) Rules, 1987 is adopted.

2. The applicant in this OA has sought fixation of pay in the pay scale of Rs. 16400-22400 w.e.f. 1.1.96 and also to allow him in his present post of Dean till the date of superannuation i.e. 31.01.2001.

3. When the matter was referred to the Full Bench with reference "Whether it would be in order, in the circumstances of this case, to follow the judgment rendered by the Division Bench of this Tribunal in OA No.2707/2000-Professor **U.C. Jindal v. Union of India & Others** and to pass further order as might considered necessary in the circumstances of the case". The reference was answered holding that the order of the Division Bench of the Tribunal in OA 2707/2000 would govern the field.

4. As we find in OA 2707/2000, the relief sought was grant of higher pay scale and enhancement of retirement age, the finding recorded has treated the applicant therein entitled for being placed in the higher pay scale of Rs.16400-22400 w.e.f. 1.1.96, the request of enhancement was turned down. Accordingly, in all fours, as per the Full Bench decision in **U.C. Jindal** (supra) covers the present issue. Partly allowing the OA, rejecting the request of enhancement of age, we direct respondents to place the applicant in the higher pay scale of Rs.16400-22400 w.e.f. 1.1.96 as University Teacher/Professor with all consequential monetary benefits and arrears, which shall be disbursed to him within a period
