

By Justice Ashok Agarwal, Chairman

Respondents have issued a Notification of 27.6.2001 at Annexure A-2a proposing to fill up 11 posts of Junior Engineer-I Grade 6500-10500, 9 from the General category, 1 from the Scheduled Caste and 1 from Scheduled Tribe. By the present OA, applicant seeks direction to the respondents to fill up additional posts which according to the applicant are lying vacant. How many posts are lying vacant and how many are filled up is entirely within the domain of the respondents. Applicant ~~can~~ have no <sup>say</sup> ~~cause~~ in the matter.
