O R D E R (ORAL)

By Justice Ashok Agarwal, Chairman

On application made by Shri K.K. Patel,  
applicants no. 3 and 4 in OA-2442/2001, 5 and 6 in  
OA-2443/2001 and 5 in OA-2441/2001 are dropped with  
liberty to the said applicants to institute fresh  
proceedings on the same cause of action.

2. Present set of applications raise common

question of facts and law and hence the same are being disposed of by the present common order.

3. Applicants in the present OAs are Office Superintendents grade-I/II in the Northern Railway. Certain candidates belonging to Schedule Caste and Scheduled Tribe category were earlier promoted to the aforesaid posts of Office Superintendents grade-I/II on account of accelerated promotions granted to them due to reservations. On promotion of the applicants to the said posts, they claimed their original seniority over and above the Scheduled Caste and Scheduled Tribe candidates who had earlier been promoted on account of accelerated promotions. Aforesaid claim is based on a decision of the Supreme Court in the case of Ajit Singh & ors.(II) vs. State of Punjab & ors., (1999) 7 SCC 209 which has inter-alia ruled as under:

"92. Where before 1.3.1996, i.e. the date of Ajit Singh judgement(1) at Level 3, there were reserved candidates who reached there earlier and also senior general candidates who reached there later (but before the reserved candidate was promoted to Level 4) and when in spite of the fact that the senior general candidate had to be treated as senior at Level 3 (in view of Ajit Singh(1), the reserved candidate is further promoted to Level 4 - without considering the fact that the senior general candidate was also available at Level 3 - then, after 1.3.1996, it becomes necessary to review the promotion of the reserved candidate to Level 4 and reconsider the same (without causing reversion to the reserved candidate who reached Level 4 before 1.3.1996). As and when the senior reserved candidate is later promoted to Level 4, the seniority at Level 4 has also to be refixed on the basis of when the reserved candidate at Level 3 would have got his normal promotion, treating him as junior to the senior general candidate at Level 3. Chander Pal vs. State of Haryana has to be understood in the manner stated above."

4. In our view, if one has regard to the aforesaid decision of the Supreme Court, the claim made by the applicants, we find, is well founded and the same deserves to be granted. In the circumstances, we direct the respondents to recast the seniority in terms of the aforesaid decision of the Supreme Court in the case of Ajit Singh (supra). This be done expeditiously and within a period of two months from the date of service of a copy of this order. It goes without saying that till such time the seniority list is recast in terms of the aforesaid decision, respondents will not order further promotions. Present OAs are disposed of in the aforesaid terms with no order as to costs.
