1. M.A. 1410/2001 for joining allowed.

Through this OA 23 persons who are working as Home Guards with Delhi Home Guards Organisation are seeking Tribunal's interference, against discharging them from functioning as Home Guards though all of them have got tenures which would extend to various dates in 2003-04. The applicants' desire is that their case may be dealt with and disposed of in terms of Tribunal's judgement dated 5.3.2002 in OA No. 270/2002 where under the guide-lines issued by Delhi Home Guards office had been quashed and set aside.

3. I have considered the matter and I am convinced that in the interest of justice would be served by directing the applicants' to act in accordance with the decisions of the Tribunal in OA 270/2002 issued on 5.3.2002 and followed in other OAs No.1994, 2627, 2657, 2850 of 2001 and 3105/2001 dated 220.3.2002 and 22.3.2002, I order accordingly, without issuing any notice to the respondents. The respondents shall act in accordance with the decisions of the Tribunal in above OAs and they shall not dispense with the services of the applicants before their terms extended upto various dates in 2003-04 are over.
