O R D E R (ORAL)

(Hon'ble Smt. Lakshmi Swaminathan, Vice Chairman (J))

In both these two Original Applications, the applicants who are Trained Graduate Teachers (TGTs), have claimed refixation of their pay in the revised pay scale of Rs.5500-9000 from the respective dates of their promotion.

2. When these OAs were taken up for final hearing today, learned counsel for the parties have drawn our attention to the orders issued by the Govt. of India, Ministry of Human Resource Development, Department of Secondary and Higher Education dated 4.4.2002 (Annexure A 1 annexed to MA 914/2002). From this clarificatory letter, it is noticed that the respondents have taken a decision regarding the anomaly in the pay scales (senior and selection) of Primary School Teachers and decided to revise senior and selection scales of these teachers w.e.f. 1.1.1996, to the scale of Rs.5500-9000. The applicants had demanded that this should be done and they be given senior


scale of ^{pay of Rs.} Rs.5500-9000. In the light of the decisions of the Govt. of India conveyed to the respondents in the aforesaid applications dated 4.4.2002, learned counsel for the applicants as well as the learned proxy counsel for the respondents submit that nothing further survives in these two OAs as the demand of the applicants has been met.

3. Noting the above facts and the submissions of the learned counsel, OA 3248/2001 with MA 2679/2001 and OA 3101/2001 are disposed of. The respondents to pass consequential orders as expeditiously as possible. No order as to costs.
