Applicant claims in situ promotion in Grade Rs. 1350-2200

(RPS)/Rs. 4500-7000 w.e.f. 1.9.1995 with all consequential  
benefits including interest @ 18% p.a.

2. None appeared for the respondents on the last two  
consecutive dates, and we also note that although OA was filed  
as far back as on 16.3.1999, and adequate time was granted to  
the respondents to file their reply, they have not filed the  
same.

3. Furthermore, we note that applicant had filed a  
representation dated 31.7.95 (Page 8 of the OA ) for in situ



We dispose of this OA with a direction to the respondents to examine the contents of the applicant's aforesaid representation dated 31.7.95, and pass a detailed speaking and reasoned order thereon in accordance with rules and instructions under intimation to the applicant, as expeditiously as possible and preferably within a period of three months from the date of receipt of a copy of this order.
