2. For the reasons given in order dated 12.7.2000 in Arvind Kumar & Ors. Vs. Govt. of NCT, Delhi & Ors. (OA 408/2000 with connected cases), O.A.420/2000 and O.A.1806/1999 also succeed and the applicants are entitled to similar benefits as have been accorded to the applicants in those cases.
