ORDER (Oral)

O.A. No. 1332/98 was disposed of vide order dated 22.7.98 (Annexure A-3) directing the respondents to decide applicants' objections to provisional seniority list published on 1.4.97 and publish the final seniority list within a period of four months. The respondents published the final seniority list on 2.9.98 (Annexure A-2) which has been impugned in the



present proceedings. Shri Rajeev Bansal, learned counsel of the respondents pointed out that applicants' representation dated 30.9.1998 (enclosed with Annexure-A-4) against final seniority list dated 2.9.98 is still under consideration of the General Manager (P), Northern Railway, New Delhi. The applicants have also stated that the respondents have yet not considered their representation dated 30.9.98. In our view, at this stage, it will be fit and proper to direct the respondents to decide applicants' representation dated 30.9.98 within a stipulated period.

2. The OA is disposed of directing the respondents to decide applicants' representation dated 30.9.98 against seniority list dated 2.9.98 by passing a detailed and speaking order within a period of three months from the communication of this order. The applicants will have liberty to challenge the order on their representation dated 30.9.98 in case they remain aggrieved. No costs.
