Both the learned counsel submit that the issues and facts raised in the aforesaid four OAs are similar. Accordingly, these OAs are being disposed of by a common order.

2. Learned counsel for the applicants as well as for the respondents submit that the aforesaid four OAs are on all fours with the order in Kamal Vs. DG, ESIC & Ors (OA 1685/99 with connected six cases) which were disposed of by Tribunal's order dated 18.1.2000.

3. In the above facts and circumstances of the case, these three OAs, namely, (OA 1920/99, OA 1972/99 and OA 1973/99) are disposed of in terms of the aforesaid order dated 18.1.2000 and the applicants shall be entitled to similar benefits. No order as to costs.
