ORDER (ORAL)

By Hon'ble Mr. Justice, V.Rajagopala Reddy, VC (J):-

The only grievance in this case as against the promotion of alleged juniors to the applicants in the post of Sr. Electric Asstt.

2. It is seen from the record that the applicants have not made ~~as~~ parties <sup>affected</sup> to the persons who have already been promoted in the year 1997-98. Unless these persons are made parties, no relief can be granted to the applicants in this OA as they are the necessary parties and they are entitled to be heard.

3. In the circumstances, the OA, ~~therefore~~, fails on ground of non-joinder of necessary parties. It is, however, open to the applicants to file a fresh OA on the same cause of action after <sup>Amplifying</sup> ~~making~~ the necessary parties.
