Applicants impugn seniority list dated 9.1.1998 (Annexure A-1) and seek a direction to respondents to prepare the seniority list, in accordance with the Tribunal's judgement in OA No. 473/89 stated to be upheld in Supreme Court SLP No. 15106/91.

2. None appeared for the applicant even on second call. Shri A.K. Bharadwaj appeared for respondents and has been heard.

3. We note that the Tribunal's order in OA No. 473/89, is an order passed by CAT Ernakulum Bench in V. Narayanan and 3 ors. Vs. Collector of Central Excise and Customs, Cochin, 18 and 19 others reproduced in (1992) 19 Administrative Tribunals Cases 198. Clearly the aforesaid order in V. Narayanan's case (Supra) relates to the Central Excise and Customs Department while the impugned seniority list relates to the department of Telecom and is stated to have been prepared in compliance with the Hon'ble Supreme Court judgement dated 8.7.1997 in CA Nos. 3207-3210 of 1995 I.K. Sukhija & Ors. Vs. Union of India and Ors.

4. Shri Bharadwaj's asserts that the impugned seniority list dated 9.1.1998 had been prepared in respect of the department to which applicants belong and has been prepared strictly in accordance with the Hon'ble Supreme Court decision in the case of I.K. Sukhija and Ors. (Supra).
