

ORDER (ORAL)

By Mr. Justice V. Rajagopala Reddy. Vice-Chairman (J):

The only grievance of the applicants who are Cooks in the Delhi Police is that they have no promotional avenues. It is stated that they have been appointed as Cooks during 1975 to 1988 and they would retire as Cooks. Since it has been well settled that there should be at least two promotional avenues in a service and the only grievance of the applicants is that their representations for the above purpose have not been considered so far by the respondents, We direct respondent No.1, Secretary, Ministry of Home Affairs to consider the representation dated 1.11.98 of the applicants in this regard within a period of three months from the date of receipt of a copy of this order and pass a suitable order.

The O.A. stands disposed of in terms of the same order.
