ORDER  
Hon'ble Shri S.P. Biswas, Member(A)

In all these 38 original applications, the applicants have raised common questions of law, have brought out identical background facts and issues and have sought for similar reliefs and hence they are being disposed of by a common order. For the purpose of maintaining consistency in respect of elaborating the issues involved in these OAs, details available in three OAs, namely, 673/99, 678/99 & 749/99 have been taken as representative ones.

2. Applicants in all the aforesaid OAs are aggrieved because of a provision in the appointment orders issued on various dates in June 1998. These orders contain that appointments would stand automatically terminated on 31.3.99. In specific terms, applicants are challenging the following provisions in the impugned appointment letters:-

"Para-1 The appointment will be effective from the date of engagement of the teacher upto 31st Dec. 98. It may be further extendable upto 30.04.1999 on the same or fresh terms and conditions. The appointment will stand terminated on 31.12.98 or when the post is filled up on regular basis, whichever is earlier. It can be extended before 31.12.98 upto 30.04.99 and in no case beyond 30.04.99 and will stand automatically terminated on that date.

Para-2 This appointment can be terminated by giving one months notice or one months remuneration in lieu of the notice. For such termination on contract no reasons would need to be communicated."

3. They also challenge respondents subsequent orders dated 29.12.98 (Annexure A-3) which stipulates that "the teachers of contractual appointee will continue to draw their existing monthly remuneration upto 31.3.1999. Their services will automatically stand terminated after 31.3.99." The applicants are equally aggrieved by the respondents denial to give them the same pay scale, allowances and other service benefits like leave, provident fund and medical attendance benefits etc. as otherwise admissible to regularly appointed teachers. Consequently, all the applicants have sought relief in terms of issuance of directions to respondents for (i) not disengaging them from their respective posts so long such vacancies exist, (ii) for preventing the respondents from replacing the applicants by teachers appointed on contract/ad hoc basis, (iii) directing the respondents to grant them the same pay scale, allowances as also benefits of maternity leave etc. admissible to those holding regular posts, and (iv) considering the applicants cases for regularisation, on relaxed standard, by giving them the benefit of length of service they have already put in.

4. A brief mention of the background facts will be necessary to appreciate the issues involved in these applications. The Government of NCT have a large number of vacancies of teachers particularly in schools located in resettlement colonies, slum areas and remote villages where regularly appointed school teachers are not willing to serve. There are more than 3000 vacancies of teachers in the three grades, namely, Asstt. Teachers, TGT and PGT

for various subjects in the schools under the control of the respondents. Some of the schools are being run on the strength of almost 40% of the teachers being appointed on contract basis as against the regular strength therein. It is in the background of such a large number of continuing vacancies that the respondents decided to appoint teachers on short terms contract basis to take care of emergent situation. The advertisement in Hindustan Times/New Delhi on 7.4.98 specifically mentions of "appointments of teachers on contract basis" and also stipulates location of schools, the nature of salary (consolidated) and other details of requirements for the purpose of appointing teachers on contract basis. All the applicants applied in follow up of the aforesaid advertisement and were appointed pursuant to selection proceedings conducted by the respondents on the basis of several norms worked out by them in the month of May 1998. The norms followed by the respondents were on the lines of provisions under the relevant recruitment rules.

5. Fairly a large number of applicants apprehending termination of their services as per clauses contained in the appointment letters approached this Tribunal on 23.3.99 and obtained stay orders restraining the respondents from terminating their services. Many of them also agitated their grievances before this Tribunal on the last day i.e. 31.3.99 and obtained interim orders in terms of maintaining status quo as on that date. Applicants have assailed the threatened orders of termination as in the appointment letters on several grounds as mentioned hereunder:

6. The main plank of applicants attack is on the basis of the orders of this Tribunal in the case of Sangeeta Narang & Ors. Vs. Delhi Administration (ATR 1988(1) CAT 556). The decision of this Tribunal in the aforesaid case was upheld by the Hon'ble High Court of Delhi vide its order dated 11.9.98. The Government of NCT filed an SLP against the order of the High Court in the case of Government of NCT of Delhi & Anr. Vs. V.S. Chauhan & Ors. and that was dismissed by the Apex Court vide its order dated 1.2.99. That was the case where the same respondents had appointed several doctors on monthly wage contract basis for short period of three months, six months etc. This Tribunal held that such appointees are entitled to (i) the same pay scale, leave and other conditions of service as regular appointees and (ii) continuance in service till regular appointments are made to fill up those posts.

7. Citing the decisions of the Apex Court in the case of Roshan Lal Tandon Vs. U.O.I. (1968(1) SCR 185) and U.O.I. Vs. Arun Kumar Roy (1986(1) SCR 136), Shri KNR Pillai, learned counsel for the applicants in OA-673/99 argued that a government servant whose appointment though originates in a contract, acquires a status. The terms and conditions of an employee under the Government who enters service on contract basis will, once he is appointed, be governed by the rules governing his service conditions. The position of law as laid down in the aforesaid judicial pronouncements stipulates that the

terms in the offer of appointments cannot prevail over the rules notified under Article 309. In other words, the applicants herein will be governed by the CCS (Temporary) Rules so far as their services are concerned and the provisions under Fundamental Rules so far as pay and leave matters are concerned.

8. Drawing strength from the judgement of the Hon'ble Supreme Court in the case of Central Inland Water Transport Corporation Vs. Brojo Nath Ganguly (1986(3) SCC 156), the learned counsel argued that such harsh terms in the appointment letters denying pay of the posts, leave and other service benefits and providing for automatic termination by a fixed date when large number of regular vacancies exist cannot be enforced by Courts since the agreements were not between parties with equal bargaining power. An employment seeker who is in miserable condition of acute unemployment prevalent in the country is forced to sign on the dotted line to get a job and cannot be held down by the terms accepted.

9. Again, the case of Dr. A.K. Jain & Ors. Vs. U.O.I. (JT 1987(4) SC 445) was cited to advance the contention that in such circumstances regular candidates selected by the UPSC were first be posted in vacant slots and only when vacant posts are not available the regular appointee shall be adjusted against the posts held by ad hoc appointees. Replacement of the latter should be on the principle of 'last come first go'. In this case, their Lordships also held that ad hoc appointees shall be

paid the same salary and allowances as regular appointees and that no ad hoc appointee shall be replaced by newly appointed ad hoc employee. To buttress his contention, the learned counsel for the applicants also drew our attention to the decision of the Apex Court in the cases of State of Haryana Vs. Piara Singh (JT 1992(5) SC 179) and Karnataka State Stop-gap Lecturer's Association Vs. State of Karnataka (JT 1992(1) SC 373).

10. The learned counsel then took us through the details of the judgement in the case of Rattan Lal Vs. State of Haryana (1995(4) SCC 43) decided by the Hon'ble Supreme Court. Therein teachers were being appointed on ad hoc basis at the commencement of the academic year and were being terminated immediately before the vacation. Applicants would submit that the facts and circumstances of Rattan Lal's case, on all fours, are identical with the facts and circumstances of applicants case herein, and sought to bring out on sharp focus the following portion of the judgement in the aforesaid case. It was said therein that:-

"If the teachers had been appointed regularly, they would have been entitled to the benefits of summer vacation alongwith the salary and allowances payable in respect of that period and to all other privileges such as casual leave, medical leave, maternity leave etc. available to all the Government servants. These benefits are denied to these ad hoc teachers unreasonably on account of this pernicious system of appointment adopted by the State Government. These ad hoc teachers are unnecessarily subject to an arbitrary 'hiring and firing' policy. These teachers who constitute the bulk of the educated unemployed are compelled to

accept these jobs on an ad hoc basis with miserable conditions of service. The Government appears to be exploiting this situation."

11. Shri S.K. Sinha, learned counsel for applicants in OA-678/99 and Ms. Raman Oberoi with Sh. K.R. Sachdeva, learned counsel in OA-749/99 argued to say that the case of the applicants is at par with the doctors in Sangeeta Narang's case and that the respondents have acted in violation of the provisions of Article 21 of the Constitution. While Shri Sinha contended that clause-1 of the appointment letters demolishes itself, Ms. Oberoi argued that the respondents are at fault for applying two different criteria in effecting termination. That in the schools under West Delhi zone, the terminations have been effected from 30.4.99 whereas those in the South Delhi zone the terminations have been made operative from 30.3.99. She also mentioned that similar unhappy turn of event surfaced in 1994-95. Both the counsel, however, adopted the submissions of Shri Pillai in respect of applicants stand in paras 6 to 10 in this order.

12. Shri Vijay Pandita, learned counsel for the respondents submitted that these OAs are liable to be dismissed on the ground that the applicants being contract employees are governed by the conditions given in the offer of appointment letters in which it is specifically mentioned that the appointments will be effective from the date of engagement upto 31.12.98. Once the applicants have accepted the terms of conditions, they are estopped to make claims otherwise. It has been submitted that the applicants had given undertaking that they will have no objection to the services being terminated at any moment.

In support of this contention, the learned counsel for the respondents relied upon the decision of the Apex Court in the case of State of Gujarat and another Vs. P.J. Kampabhat (1992(3) SCC 226).

13. It was contended that the staff working on contract basis is only about 3% of the total strength of working teachers which could be easily managed by the concerned Principals/Dy. Directors. In these circumstances, the department does not require the services of the teachers on contract basis and as such period of the contract could not be extended beyond 31.3.99. Keeping in view of the fact that the summer vacations are coming, it will be an extra burden on the national exchequer if the teachers were to be paid for no work.

14. The respondents have further argued that the appointments of the applicants on contract basis were not according to the rules. Such appointments cannot be covered under the benefit of "equal pay for equal work" and, therefore, they are not entitled to the benefits of regular pay scale in terms of the orders of the Apex Court in the case of State of Haryana Vs. Surinder Kumar (1997(3) SCC 633) and Ashwani Kumar Vs. State of Bihar (1997(2) SCC 1). In the latter case, the Apex Court held that appointments following procedures contrary to relevant recruitment rules is illegal. It was further submitted that in the case of termination of employees, appointed originally on the basis of contract, no writ or

mandamus can be issued by the Court/Tribunal. Drawing strength from the judgement of the Apex Court in the case of Shankarsan Dash Vs. U.O.I. (1991(3) SCC 47), it was argued that even if the number of vacancies are notified for appointment and adequate number of candidates are found fit, the successful candidate does not acquire an indefeasible right to be appointed. Ordinarily the notification merely amounts to an invitation to the qualified candidates to apply for recruitment and on their selection they do not acquire any right to be posted against a regular vacancy. Unless the relevant recruitment rules so indicate, the State is under no legal obligation to fill up all or any of the vacancies. The contract employees do not have any right for regularisation. Appointments being purely of ad hoc nature and on contractual basis and that too being for a limited period, the right to remain in the post would come to an end by the expiry of the period itself. In support of this contention, the learned counsel for the respondents relied upon the decision of the Apex Court in the case of State of Himachal Pradesh Vs. Suresh Kumar Verma (JT 1996(2) SC 455).

15. Learned counsel for the respondents also cited the judicial pronouncements of the Apex Court in the following cases : (i) J.K. Public Service Commission etc. Vs. Dr. N. Mohan and Ors. (1994(1) SLJ 218); (ii) The Govt. of A.P. and Anr. Vs. A.V. Venugopala Rao (Vol.103 1995(1) SLR 44 and (iii) C.K. Antony Vs. B. Muraleedharan and Ors. (1998(6) SCC 630). The first one

was quoted to say that regularisation of back door entrants is impermissible, while the second and third ones were intended to highlight that Tribunal/Court are not to interfere in the interim arrangements and that a person appointed to a post on stop-gap arrangement cannot be considered as having been appointed to a regular post.

16. As per respondents with the change of the Government, the policy can differ and the Court can not compel the Government to change its policy which involves financial burden on it. Such steps taken by the respondents are in line with the judgements of the Apex Court in the case of U.O.I. Vs. Tej Ram Parashramji Bombhate (1991(3) SCC 11).

17. In the background of the circumstances aforementioned, the only issue that falls for determination is whether respondents actions in terminating the services of applicants could be legally sustained when there are regular vacancies available?

18. We have heard the learned counsel for all the parties and perused the records. A close scrutiny of official files made available to us reveals that a large number of regular vacancies of PGT/TGT and Asstt. Teachers exist in several schools. Categorywise vacancies as has been brought out in the concerned file as on 1.7.98

in almost all the districts is reproduced below:-

19. We find that the respondents in para-2 of their counter dated 6.4.99 have admitted "that the Government felt it necessary to appoint teachers due to acute shortage of teachers in schools and poor results in the Board Examination due to not filling of the posts. Vacancies in various schools have to be filled by the selection by the Delhi Subordinate Services Selection Board (D.S.S.S.B. for short). Till then the alternative arrangement was made for benefit of the children and their education." It is apparent from their submissions in the same counter that the respondents wanted to avoid making payments to the teachers for the summer vacation period.

20. We find that the issues entirely of identical nature were examined by High Court of Punjab & Haryana in the case of Polu Ram & Ors. Vs. State of Haryana (CWP No. 18835) decided on 17.4.98. That was the

case where the petitioners were working as Lectures, Masters/Mistresses, Classical & Vernacular Teachers and JBT Teachers etc. The CWPs were filed for quashing the terms and conditions of the appointment letters and also seeking direction to the respondents to pay them salary in the regular pay scale and also to allow them to continue in service till regular appointments are made in accordance with law. The High Court held that the condition of limiting the appointment of the petitioners to 89 days is ante thesis of doctrine of equality in the matter of employment, as embodied in Articles 14 & 16 of the Constitution. While deciding this case, the High Court of Punjab & Haryana referred to 10 such CWPs which they had decided earlier on the similar issues between 1988-96. It was further held that "we find considerable merit in the argument of the learned counsel for the petitioners that the decision of the respondents to pay fix emoluments to their clients is violative of Articles 14 and 16 read with Article 39(d) of the Constitution." We find the same situation prevails in these OAs.

21. We have had the opportunity of going through all the case laws cited by the learned counsel for the respondents. We consider that it is not necessary to burden this order with the details therein. Suffice it to say that facts and circumstances as well as issues raised and examined therein are distinguishable from those before us.

22. From pleadings and records made available to us, the following facts emerge as undisputed by both sides:-

- (a) That as on date no candidate duly recommended by DSSSB, after holding final selection, is in the waiting for regular appointment.
- (b) In some of the schools "for example at Nithi Hari & Block P. Mangolpuri" almost 40% of the presently working teachers are those having been appointed on contract basis.
- (c) Even in the month of March 1999 there are sufficient number of regular vacancies in respect of male and female teachers in both TGT and PGT categories. The fact that such vacancies are available gets well confirmed when it is seen that the respondents themselves have notified to DSSSB on 1.3.99 as many as 393 vacancies of teachers in different categories asking applications latest by 25.3.99 (Hindustan Times dated 1.3.99).
- (d) The position as regards availability of regular vacancies gets again reconfirmed in the statement of Minister of

Education/ Govt. of NCT on 8.4.99 in the State Assembly indicating vacancies as under:-

Lecturer	650
T.G.T.	2491
Other Category Teacher	989

N.B. This was the position before termination orders were issued.

(e) Many of the teachers have worked for more than 240 days admittedly entitling them to claim temporary status.

(f) Occurrence of such vacancies in Education Department under the Government of NCT/Delhi is a continuing event every month in any year.

23. In the background of the admitted facts as aforementioned, the law laid down by the Apex Court in the case of Rattan Lal (supra), the ratios arrived at in Sangeeta Narang's case (supra) by Delhi High Court (as subsequently upheld by Supreme Court) and the decisions of Punjab and Haryana High Court in Polu Ram's case (supra) will be squarely applicable. In the Rattan Lal's case, the Apex Court directed the respondents to take steps to make appointments according to recruitment rules and till

then the ad hoc appointees were to continue with the same pay and allowances as regular teachers. Their Lordships also held that while selecting the regular appointees, the ad hoc appointees were to be given relaxation in terms of age and qualification.

24. Perusal of records also reveal that the Education Department in the middle of March 1999 thought it proper to order DSSSB to go for special recruitment and a list was also ordered to be prepared of "all those schools which are in interior areas and do not have adequate number of teachers. A separate advertisement could be given in papers only for these schools and teachers could be appointed on contract basis, till teachers are appointed on regular basis." This was the view taken on 17.3.98 by no less than the Principal Secretary (Education). Respondents were thus aware of the legal position. Files/documents handed over to us do not contain any details, much less convincing reasons, as to why with the change of Government and policy, the services of the applicants were to be terminated deviating from their (respondents) own stand.

25. Study of the records placed before us leave us in no doubts that the jobs held by the applicants are of perennial nature. And in answer to a pinpointed question of ours, the learned counsel for respondents would not say, without being properly instructed by answering respondents, if those schools have been

- permanently closed or posts abolished - temporarily or permanently. In the background of the aforesaid circumstances, we allow these OAs with the following directions:-

- (A) Applicants shall be allowed to continue in the present posts till regular candidates duly selected by DSSSB/or appropriate authority are available to replace the applicants.
- (B) Those selected regularly shall first be posted in the existing vacant positions and only if enough vacant posts are not available, they should be posted against the posts held by ad hoc appointees. Replacement of the latter should be on the principle of 'last come first go'. Those so displaced should be accommodated in vacancies that may be existing in other districts.
- (C) The ad hoc appointees shall be paid minimum pay in the pay scale of regular teachers plus DA in terms of law laid down by Hon'ble Supreme Court in the case of Daily Rated Casual Labourer Vs. UOI & Ors. (1988(1) SCC 122).
- (D) No ad hoc appointee shall be replaced by any newly appointed ad hoc employee.

(E) Those of the applicants who have applied or may apply for regular selection, necessary relaxation in age shall be given to the extent of the period of service put in by them.

(F) There shall be no order as to costs.
