#### O R D E R

by Hon'ble Shri Kuldip Singh, Member (J)

1. Since all the OAs involve common points of law  
and facts, we are disposing of the above referred OAs by  
this common order.

2. Brief fact of the case is that Govt. of  
N.C.T. of Delhi had a number of vacancies of Teachers in  
different categories in the various schools. Since there

km

was a shortage of regular Teachers the Govt. of NCT of Delhi appointed applicants on ad hoc basis and that too for short periods. The said short term appointments were supposed to be automatically terminated on the expiry of the period specified in the appointment letters despite the fact that posts remained vacant even after the termination of teachers appointed on ad hoc basis.

3. In these OAs applicants have challenged that the terms of short term contracts of service are unjust, unconscionable and against the very letter and spirit of the Constitution.

4. In most of the cases the applicants' appointment was to lapse by efflux of time on 31.3.1999 and in one or two cases time period was to lapse on 30.4.1999. Applicants being threatened with the situation had rushed to this Tribunal for continuation of their services and seeking a stay order that their services may not be terminated.

5. These petitions were contested and justification for appointing teachers for short term on ad hoc basis has been given by the respondents in their reply. It was stated that the decision was taken up by the Government in December, 1998 not to fill up any further posts on contract basis any more as the posts will be filled up on regular basis from the candidates selected by the Delhi Subordinate Staff Selection Board (hereinafter referred to as DSSSB). It is further stated that it is the administrative function of Government to look into the interest of the students as well as the necessity from time to time.

6. It is also being pleaded that the candidates who are being employed on contract basis have accepted the appointment on contract basis knowing fully well the consequence of the same. Time and again the Hon'ble Supreme Court had held that regularisation of back-door entrants in service is impermissible and the Tribunals and Courts are not to interfere with the interim arrangement and a person appointed to the post as stop-gap arrangement cannot claim the benefit of continuance in service as having been appointed on regular basis.

7. Rejoinder to the counter affidavits have also been filed by the applicants in which they have reiterated the stand taken by them in their respective OAs.

8. We have heard the learned counsel for the parties and perused the material on record.

9. Before considering the rival contentions of the parties, we may mention at this stage that when this bunch of cases was filed prior to that another group of teachers who had filed a similar application before this Tribunal and since those teachers had been able to reach this Tribunal before the expiry of the contract period so an interim order was passed in their cases and status-quo was directed to be maintained. In the present set of applications, the applicants could not approach the Tribunal before the expiry of their contract period. Moreover, immediately after the expiry of their contract period there were vacations in the Tribunal from 22nd

March to 1st April, 1999 so these set of petitioners could approach the Tribunal only after the vacations. In these cases also an interim order was passed in the following terms:

"Also issue a short notice on the question of interim relief, returnable on 12.04.1999.

Till then, as an interim measure, status quo in respect of the applicant as on today be maintained."

10. Since this order in the nature of interim measure was passed after these applicants have ceased to be in employment with the respondents so they are claiming parity with those teachers who had obtained an order of similar nature before expiry of their term i.e. before 31.3.1999.

11. During the course of their arguments, the learned counsel for the applicants submitted that these present applicants are also similarly situated applicants as the applicants were placed in the earlier set of OAs which was decided on 7.5.99 (Veena Anand & Ors. vs. Govt. of NCT of Delh & Ors with connected OAs) by another Bench of this Tribunal wherein the following reliefs were granted to the applicants/teachers and their OAs were disposed of in terms of the following directions given by the Bench of the Tribunal:

"(A) Applicants shall be allowed to continue in the present posts till regular candidates duly selected by DSSSB/or appropriaite authority are available to replace the applicants.

(A7)

"(B) Those selected regularly shall first be posted in the existing vacant positions and only if enough vacant posts are not available, they should be posted against the posts held by ad hoc appointees. Replacement of the latter should be on the principle of last come first go. Those so displaced should be accommodated in vacancies that may be existing in other districts.

"(C) The ad hoc appointees shall be paid minimum pay in the pay scale of regular teachers plus DA in terms of law laid down by Hon'ble Supreme Court in the case of Daily Rated Casual Labourer Vs. UOI & Ors. (1988 (1)SCC 122).

"(D) No ad hoc appointee shall be replaced by any newly appointed ad hoc employee.

"(E) Those of the applicants who have applied or may apply for regular selection, necessary relaxation in

age shall be given to the extent of the period of service put in by them.

(AS)

"(F) There shall be no order as to costs."

12. Learned counsel appearing on behalf of the applicants submitted that since the present applicants are also similarly placed as the applicants in the case of Veena Anand & Ors. (supra), they are also entitled to the similar relief as granted to them. Learned counsel also submitted that the applicants who were, during the intervening period, not in service that does not affect the merit of their case and they can also be directed to be allowed to continue in their respective posts as the applicants in the above referred judgement.

13. To support their contentions learned counsel for applicants also relied upon the judgement of Hon'ble Supreme Court in the case of Girdhari Lal vs. Union of India which also starts with the following paragraph:

"There is no dispute that the appellant Girdhari Lal would be entitled to the benefit of the judgement of the Tribunal in OA No. 319/85 decided on 24.09.1987 in Balwant Singh & Orfs. vs. Union of India if he too was a party therein, since his claim is identical to that of the applicants therein. The main challenge on behalf of the Union of India to Girdhari Lal's claim is that he did

not join as a party in that matter and he moved the applicant for grant of the same benefit after that decision in 1989, having retired earlier".

(A9)

14. After mentioning the facts the Hon'ble Supreme Court observed as follows:

"[I]t is appropriate that the Union of India treat all such persons alike and to grant them the same benefit instead of driving each one of them to litigation in the course of which the Union of India itself is required to spend considerable public money"

15. Counsel appearing for applicants also submitted that since it has come during the proceedings before the Hon'ble High Court, that at present there are 4000 vacancies and DSSSB is also making exercise to fill up those vacancies by a regular manner, till such time the vacancies are filled up on regular basis, applicants may be allowed to continue in their respective posts.

16. Counsel for respondents rebutted the arguments of the counsel for applicants and submitted that in this manner the applicants would claim continuity and then they will claim a right to post which will ultimately lead to entry through back door. He further submitted that the present applicants cannot claim continuity in service after expiry of their term specified in their respective appointment letters and as such these OAs should be dismissed.

17. We are of the considered opinion that the contention of respondents' counsel has no merit and the present set of applicants are fully covered with the judgement given by the co-ordinate Bench of this Tribunal in Veena Anand's case (supra). In this regard we may also mention that when the interim order was granted in the case of Veena Anand (supra), the respondents had filed a Writ Petition before the High Court of Delhi for vacation of the stay, and the High Court had taken a view that the stay granted was an innocuous one because respondents were given liberty to fill up the vacancies through regular process i.e. after due selection by the DSSSB or by any appropriate authority to replace the ad hoc teachers. The High Court of Delhi was informed that the vacancies had arisen to the number of 4000 as on 8.4.1999 so the High Court was of the view that prima-faice there was a need to continue the services of the respondents (applicants in the OAs) or some of them who were still continuing there for the time being.

18. During the course of arguments, we were also informed that exams for various categories have been held very recently by the DSSSB. Since there are a large number of candidates, result of the same within a short span of time cannot be accepted. In these circumstances, we find that the applicants in the present set of OAs who just could not approach the Tribunal because of its vacations should not be denied the relief granted to their colleagues in the earlier set of OAs in Veena Anand & Ors. (supra) and if we peruse the earlier order passed in the above referred judgement by a Co-ordinate Bench of this Tribunal we find that there is no dispute about the

facts of the present set of OAs which are identical with the facts of the earlier set of OAs which was decided by the Co-ordinate Bench of this Tribunal. The present applicants are, therefore, also entitled to the same relief as granted to the applicants in an earlier set of OAs.

19. In view of what has been discussed above, we allow these OAs with the similar directions as given in Veena Anand's case (supra).

(A) Applicants shall be re-engaged on the present posts forthwith till regular candidates duly selected by DSSSB/or appropriate authority are available to replace the applicants.

(B) Those selected regularly shall first be posted in the existing vacant positions and only if enough vacant posts are not available, they should be posted against the posts held by ad hoc appointees. Replacement of the latter should be on the principle of last come first go. Those so displaced should be accommodated in vacancies that may be existing in other districts.

(C) The ad hoc appointees shall be paid minimum pay in the pay scale of regular teachers plus DA in terms of law laid down by Hon'ble Supreme

(D) No ad hoc appointee shall be replaced by any newly appointed ad hoc employee.

(E) Those of the applicants who have applied or may apply for regular selection, necessary relaxation in age shall be given to the extent of the period of service put in by them.

20. The above directions should be complied with within a period of one month from the date of receipt of a copy of this order.

21. There shall be no order as to costs.
