ORDER (ORAL)

Hon'ble Sh. S.R. Adige, Vice-Chairman(A)

Both sides heard on CP-51/2000, alleging contumacious disobedience of the Tribunal's interim order dated 13.12.99 in OA No. 173/99 inasmuch as respondents in their order dated 30.12.99 (Annexure R-1) have omitted to mention that the appointment of Sh. S. Ramamoorthy to the post of Deputy Director (Handicrafts) on officiating basis, would be subject to the final outcome of OA-173/99.

2. It has been pointed out to us that the promotion of Sh. S. Ramamoorthy was pursuant to the CAT Madras Bench order dated 25.11.99 in OA-56/98 (S. Ramamoorthy Vs. UPSC & UOI&Ors.), and is not directly connected with the OA No. 173/99. However, as in the OA No.173/99 applicants have challenged the promotions to the post of Assistant Director and Deputy Director

(Handicrafts), it is fit and proper for respondents to issue a corrigendum further to their order dated 30.12.99, mentioning that the aforesaid promotion of Sh. S. Ramamoorthy would be subject to the out come of OA-173/99.

3. Shri Sachdeva on instructions from the departmental representative, assures us that the same will be done within four weeks and in the event of any further promotions made to the post of Deputy Director (Handicrafts), the aforesaid observations of the Tribunal dated 13.12.99 in OA-173/99 would be kept in mind. Noting this assurance given by Sh. Sachdeva upon instructions from the departmental representative, the CP is dropped and notices are discharged.

4. Pleadings in OA No.173/99 are complete. Admit. List it for final hearing in its own turn.

5. Let copy of this order be placed in OA case record also.
