They want increase in their pay scale from Rs.1400-2300 to Rs.1600-2600/1640-2900. Fixation of pay scale is a matter to be considered by expert bodies like the Pay Commission. We do not have any power with us to direct increase in the pay scale of the applicants for the reasons stated by them in their application.

2. The next relief claimed is for directing the respondents to frame Recruitment Rules with appropriate promotional avenues. This is also a matter where we cannot interfere. There must be some reason why Recruitment Rules are not framed so far. We hope and trust that the respondents will frame the Recruitment Rules within a reasonable time.

3. Subject to observations aforesaid, this O.A. is hereby summarily dismissed.
