2. Both sides admit that the claims of the applicants in the present OAs are fully covered by the Bangalore Bench of the Central Administrative Tribunal's order dated 10.01.2000 in OA-1158/98 (M. Panner Selvan & Ors. vs. U.O.I. & Ors.) read with OA Nos. 1022 & 1062 to 1170 of 2000 dated 02.05.2001 also decided by the Bangalore Bench of the Tribunal.

3. In this connection, applicants have raised the point that in the Tribunal's order dated 10.01.2000 in OA-1158/98, it has been observed that the Department of Personnel & Training as well as the Finance Ministry had turned down the proposal for parity in pay scales, ^{but} merely because the parity claimed had been turned down by those departments, could not be treated as a conclusive reason to deny applicants the benefit of parity, if the same was otherwise justified on merits.

4. Be that it may, as both sides admit that the claims of the applicants in the present OAs are fully covered by the aforesaid two rulings of Bangalore Bench of CAT, we dispose of these OAs in terms of the said two rulings and direct the respondents to ensure that whatever benefits flow out of the aforesaid two

rulings of Bangalore Bench of the Tribunal should also be extended mutatis mutandis to applicants in the present set of OAs, within three months from the date of receipt of a copy of this order. No costs
