The applicants seek pay parity with Refrigerator Mechanics Highly Skilled in the scale of Rs.950-1500. In the counter the respondents aver that the applicants are not entitled for the higher scale

of the Refrigerator Mechanics Highly Skilled Gr.II as their duties and responsibilities are nowhere equal to their duties. Law is well settled that it is not possible for us to decided as to <sup>unequalities</sup> ~~unequalities~~ of the posts in the absence of any hostile discrimination. The OA is, therefore, disposed of directing that in case the applicants file a proper representation, within a period of three weeks from today by giving reasons in support of their claim, how they are entitled for the higher pay scale, Respondents No.1 and 2 to dispose of that representation within three months from the date of receipt of such representation by passing a speaking order and communicate the same to the applicants the decision arrived at.
