O R D E R (ORAL)

Mr. Justice Ashok Agarwal, Chairman:-


The applicant was working as Stenographer Grade II in Headquarters Delhi Area. While so working, he was empanelled for promotion to the post of Stenographer Grade-I. He was, however, erroneously promoted as Steno Grade-I in Headquarters Area, Delhi itself although no post of Grade-I existed in the Establishment of Headquarters, Delhi Area. Hence, the aforesaid promotion for the post of Steno Grade-I in Headquarters Delhi was cancelled and a fresh order was issued promoting him against a vacancy of Steno Grade-I in Headquarters Western Command where a vacancy existed. Applicant



instead of joining in pursuance of the said order of promotion, chose the filing of one OA No.1216/98. After disposal of the OA, the applicant has been promoted to the next grade of Sr.P.A. and has assumed the office at Chandimandir, Headquarters Western Command, Chandimandir.

2. In our view, no exception can be <sup>had</sup> ~~done~~ to the orders which are passed and impugned in the present OA. Promotion to the post of Steno Grade-I in Headquarters Delhi Area was an apparent mistake. The same was corrected by directing his promotion in the Headquarters Western Command. Applicant has thereafter been promoted to the next promotional post, namely, Sr. P.A. No grievance can, therefore, be justified ~~made~~ to be made by the applicant in the present OA.

3. The present OA is, therefore, rejected. There will be no order as to costs.
