ORDER (Oral)

S.R. ADIGE, VC (A)

As both O.As involve common questions of law and fact they are being disposed of by this common order.

2. In both O.As applicants who are working as cooks in various establishments outside canteens under Defence Ministry seek the following reliefs

- i) Pay parity atleast equal to that of canteen cooks i.e. the scale of Rs.3050-4950;
- ii) To declare cook trade to be technical;
- iii) Promotional avenues to be allowed to cooks;
- iv) To allow summer/winter uniforms to cooks like other Class IV employees in all offices of Government of India.

3. Heard both sides.

4. We note that by Defence Ministry's order dated 28.3.2001 cooks/head cooks in the Messes/Inspection Bungalows etc. outside the canteens under Defence establishment have been granted the scale of Rs.3050-45901 w.e.f. 1.1.96.

Pursuant to the aforesaid order dated 28.3.2001, Air Headquarters have also issued order on 19.4.2001 classifying posts of cooks in Air Force from Group D to Group C.

5. Under the circumstances the main grievances of applicants in both O.As have been redressed. However, Respondents should ensure that their aforesaid own orders are fully implemented within three months from the date of receipt of a copy of this order.

6. In so far as the question of declaring cooks trade to be technical is concerned as also for adequate promotion avenues for applicants it will be open to them to take up the same separately with respondents if so advised.

7. As applicants have now been categorised as Group 'C' employees, the prayer for allowing summer/winter uniforms cannot be acceded to as the same is admissible only to Group 'D' employees in Government of India offices.

7. The O.A. stands disposed of in terms of foregoing paragraphs. No costs.
