
The applicants in this O.A. are aggrieved
that although they have been working as Copyists in ^{the} Song
and Drama Division, with the respondents for more than
23-28 years, the respondents are not giving them any


promotional avenues despite favourable recommendations of the 5th Pay Commission and the draft recommendations of the Cadre Review Committee.

2. Ld. counsel for both the parties have drawn our attention to the reply of the respondents wherein it has been stated that the respondents will be in a position to provide promotions and the proposed pay-scale to the applicants, as recommended by the 5th Pay Commission, upon receipt of the Ministry of Finance orders. We also note the facts mentioned, in particular, in paragraphs 4-7 of the reply.

3. In view of the above facts stated by the respondents themselves in their reply and the submissions made by the ld. counsel for applicants that he will be satisfied if a direction is issued to the respondents to take ^a final decision in the matter which is pending with them for quite some time, we dispose of this O.A. with the directions: ~~that~~ Respondents shall further consider and take appropriate decision in the matter of affording promotional avenues to the applicants and pay-scales, as recommended by the 5th Pay Commission as well as ^{the} Cadre Review Committee, as early as possible and preferably within six months from the date of receipt of a copy of this order.

4. The O.A. is disposed of with the above directions. No order as to costs.
