O R D E R (ORAL)

Shri Justice K. M. Agarwal -

Heard the learned counsel for petitioners on the contempt petition.

By order dated 11.11.1996, this Tribunal directed the respondents to consider the request of the applicants for appointment with special stress on the cost benefit analysis aspect of the situation, within a period of three months from the date of the order. The order was served on the respondents on 19.11.1996. Under the circumstances, it is too early to say if any deliberate act of contempt has been committed by the respondents. Accordingly, with liberty to the petitioners to renew the petition in future in case the order is not complied with, the present petition for contempt is hereby summarily dismissed.
