2. According to applicants, the increase is not justified and there is no occasion for the same. They submit that power and water are obtained by respondents from various Electricity Boards and Water Authorities, and that something unconsciously higher than the rates paid by respondents to the said agencies are levied under the impugned orders. Learned counsel for applicants in O.A. No. 559/1996 submits that the Orissa Electricity Board supplies power at the rate of paise 80 per unit for the first 200 units to respondents and that power so obtained is sold to applicants at Rs. 1.80 per unit. There is no justification for such a steep increase in rates by an agency of State, submits counsel. Retrospective increase in rates is also challenged.

3. Learned counsel for respondents submits that the retrospective increase has been withdrawn and that the increased rates will be charged only from 1.9.1994, September 1994 being the month in which the increase has been ordered. It is therefore, unnecessary for us to consider the validity or legality of retrospective increase in rates. The main argument of applicants centres round the

propriety in increasing the rates. It is not for courts or tribunals to go into the cost structure or prescribe price line, be it the matter of electricity or water tariffs or the matter of railway freight or passenger tickets. These are matters at least outside the jurisdiction of the Tribunal and hence not justiciable. It may be that the Government or a public authority as a model employer, must conform to certain notions accepted in the realms of public administration in their conduct. If they do not do this (assuming they do not do it), the remedies are not judicial. If applicants are aggrieved, it is upto them to move the competent authority with their grievances. Some of the applicants submit that they propose to cut down their consumption if rates are increased and that metering system would help them do it. This is a suggestion which has to be considered. It is again for applicants to move the competent authority for redressal of their grievances.

4. With these observations, we dismiss the applications. No costs.
