2. The learned counsel for the respondents has submitted that these cases are similar to Ram Naresh Singh and Ors V. Govt. of NCT & Ors. (OA 1846/96) which has been disposed of by order dated 12.9.96 (copy placed on record).

3. In view of the above and for the reasons given in OA 1846/96 the reliefs claimed in these applications (OA 1328/91 and OA 1292/95) having become infructuous, are not maintainable and they are accordingly dismissed. No order as to costs.
