All these applications are filed by the Union of India challenging the Award/Orders of the Central Government Labour Court in Divisional Personnel Officers Vs. Central Industrial Tribunal, Jaipur and Ors, SLP No. 20141/95. The Hon'ble Supreme Court has observed as follows:

"This Court in Krishna Prasad Gupta Vs. Controller Printing & Stationery J.T. 1995(7) SC 522 has held that the Central Administrative Tribunal has no jurisdiction to entertain an application under Section 19 of the Administrative Tribunals Act against the award/order of the Labour Courts. In this case the award of the industrial tribunal is in favour of the respondent-workman. The award has been upheld by the Tribunal. Although, the tribunal had no jurisdiction to entertain the application against the award of the industrial tribunal since the same has been upheld, we are not inclined to interfere. The SLP is dismissed"

2. Even though the SLP has been dismissed, it has been observed by the Hon'ble Supreme Court that this Tribunal has no jurisdiction to entertain the applications against the award of the Industrial Tribunal and Labour Court. Accordingly, we have to hold that this Tribunal has no jurisdiction to entertain these applications. These applications are, therefore, dismissed leaving the parties to bear their own costs and making it clear that the applicants would be at liberty to seek relief before the appropriate forum.
