ORDER

HON'BLE M.R.S. R. ADIGE, VICE CHAIRMAN (A).

As these three O.As involve common questions of law and fact, they are being disposed of by this common order.

2. In all three O.As, applicants who claim to be children/wards of Railway Employees, seek a direction to respondents to consider their cases for appointment to suitable posts under 'Loyal quota' in terms of an agreement said to have been executed between the representatives of the loyal workers and the respondents, pursuant to the 1974 Railway Strike to the effect that children of all those who would work during the strike period would be given employment in the railways.

3. Shri C. D. Singh appeared for applicants in all three O.As and Shri Dhawan appeared for respondents in O.A. 2480/96. In other two O.As namely C. A. No. 2007/97 and 1877/95 none appeared for respondents. Both counsel were heard.

4. Shri Dhawan has taken certain preliminary objections in these three O.As. He has urged that these O.As are grossly time barred and hit by limitation and lack of jurisdiction under the relevant provisions of the A.T. Act, no cause of action has accrued to applicants against respondents because if the parents/guardians have any grievance for non-implementation of the terms/conditions of any agreement, on the plea that they were loyal workers in the 1974 Strike, it is they (parents/guardians) who may have a cause of action accruing in 1974 against the

respondents, some of these applicants have not indicated the names of their fathers, the post held by them etc; and the OAs suffer from non-joinder/misjoinder of parties.

5. We have considered these preliminary objections carefully, and find that the OA No. 682/85 disposed of on 24.4.95; O.As No. 630/95 and OA-632/95 disposed of on 5.4.95; O.A.No. 652/95 and OA-650/95 disposed of on 7.4.95 and O.A.No. 684/94 disposed of on 27.4.95 in which similar claims for employment of sons/daughters/dependents of the workers who were loyal during the 1974 strike, were raised, were dismissed on ground of limitation, delay and latches as well as lack of jurisdiction under Sec. 21 A.T. Act in some cases even without considering it necessary to issue a notice to the respondents.

6. We as a Co-ordinate Bench are bound by those judgments.

7. In the result, the preliminary objections of limitation, delay, latches and lack of jurisdiction under Sec. 21 AT Act raised by respondents are sustained and all these three OAs are dismissed. No costs.

8. Let copies of this order be placed on all these three OAs.
