O R D E R (ORAL)

(Per Shri Justice R.G.Vaidyanatha, Vice-Chairman)

The case was called out for final hearing. The applicants and their counsel absent. We have heard the respondents counsel Mr.R.R.Bharati and perused the materials on record. The applicants main grievance is about the seniority list. The respondents counsel brings to our notice that two more persons viz. J.B.Bansal and N.K.Bhatia had raised the same issue in O.A. No.2408/94 as has been raised by the applicants in the present case. A Division Bench of this Tribunal by Judgment dt. 12.1.1996 in O.A. 2408/94 rejected all the contentions and dismissed the application. In our view, the matter in dispute in the present case is concluded by the decision given by the Division Bench in the said case. Hence, nothing survives in the present O.A.

Accordingly, the O.A. is dismissed. No order as to costs.
